TERMS AND CONDITIONS OF BEING A SHPL IBO

I have received adequate information about M/s Saarvasri Herbs Pvt Ltd., the products it sells and the optional business opportunity it offers. I have understood the same and I am fully satisfied by it. I would like to voluntarily associate with SHPL as an Independent Business Owner (IBO), under these Terms & Conditions, detailed document of which is found on the company web site www.myshpl.com under the Contract Agreement: Code of Conduct & Code of Ethics. Upon willingly signing this document, I agree to fully abide by the Contract Agreement in letter and spirit.

- 1. I am a citizen of India, aged 18+ years. I possess a valid Permanent Account Number (PAN) and KYC (Know Your Customer) documents. I shall submit the same digitally in the IBO Back Office, within 30 days from the date of activating my distributorship, failing to which SHPL reserves the right to terminate my distributorship, without any notice.
- 2. SHPL strictly operates its business as per 'The Consumer Protection (Direct Selling) Rules 2021' issued by The Department of Consumer Affairs, Government of India and I fully agree to abide by the provisions of the guidelines as an IBO of SHPL such as carrying a SHPL ID card etc.
- 3. I agree that as an IBO, I am fully responsible for conducting my SHPL distributorship business independently, without claiming to be a part of the Company. I will not falsely represent myself in any manner that I am an employee of SHPL.
- 4. SHPL registration is absolutely free with no registration fee or membership charges, whatsoever. Its validity is lifetime without annual renewal, after the activation by way of purchasing SHPL products of my own choice. My association with SHPL as an IBO does not constitute as its franchise, and it does not require me to pay any franchise fees, whatsoever.
- 5. Applying for multiple IBO registrations by one person or single business entity is strictly not permitted. SHPL strictly follows '1 PAN 1 ID' business policy. Further, IBOs in the same household must have the same sponsor to avoid cross lining activities. Change of original sponsor is not permitted under any circumstances.
- 6. I fully understand that SHPL does not offer any financial incentives / monetary benefits on directly or indirectly referring / recruiting any number of people as either Preferred Customers or as IBOs. It offers commission only and only on the products sold by me either directly and/or indirectly in my sales network as per its business plan.
- 7. I agree that as an IBO of SHPL, I would put in my honest and sincere efforts in providing demonstration, training and ultimately selling (retailing) SHPL products to Retail Customers, within India.
- 8. While presenting SHPL products, business opportunity and the business plan to prospective customers, I agree to adhere by the terms and condition of such presentations set forth by the company from time to time, failing to which I can be terminated as an IBO.
- 9. SHPL pays periodic sales commission on sales orders received and accepted for sale of its products, to IBOs as per the terms and conditions of the SHPL Business Plan after deducting prevailing TDS. There are no admin charges.
- 10. I possess a valid PAN and I am individually responsible to pay all the existing and future central, state and local taxes including income tax, under any national, state or regulatory agency in India.
- 11. If ully understand that in order to run a financially feasible business and to comply with any possible statutory changes brought in by the national, state or local administration, SHPL reserves the right to change, upgrade, amend, revise, alter or modify any changes including but not limited to products, prices, literature, terms and conditions, policies and procedures and the business plan. Any such revisions become effective and binding on me, upon announcement on SHPL web site or any other official modes of communication and I agree to be bound by these changes.
- 12. SHPL announces all business-related updates, notices, policy changes etc. in my IBO Back Office or any other modes of official communication

- and I agree to read them regularly and update my team members about the same.
- 13. I understand that my IBO business position can be inherited or bequeathed, but cannot be transferred or assigned to anyone else during my lifetime, without the written consent of SHPL, and it will not be unreasonably withheld.
- 14. I will not use the company name, logos, trade names, sales materials, trademarks or service marks, except in product and business materials provided by the Company or approved in writing by SHPL. I understand that unauthorized use or duplication of trademarks or copyrighted materials is a violation of the law in the country.
- 15. I understand that I am morally responsible to supervise and proactively support IBOs I directly refer to in my SHPL business, in my commissionable network. I readily agree to maintain regular contact with them by way of personal meetings, telephone / mobile, emails and regular attendance at meetings or any of the above or combination thereof.
- 16. I will not make any disparaging, false or misleading statements or claims about my SHPL business position or any of the company products, including but not limited to claims that the company products, especially the Health & Wellness Products are meant to diagnose, cure or prevent diseases.
- 17. I understand that display of commission amount, bank statements, unachievable income projections and wrongful income testimonials to prospective distributors is prohibited. I will conduct myself as an esteemed IBO of SHPL in a courteous, fair and ethical manner.
- 18. Preferred Customer and IBO data is owned by SHPL and it may never be used for any commercial or business purpose other than SHPL.
- 19. During the term of this agreement and for 180 days thereafter, an IBO shall not, directly or indirectly solicit SHPL IBOs to other Direct Selling organizations or businesses or of similar nature.
- 20. SHPL shall not be responsible for acts beyond its control, but not limited to fire, flood, earthquake, storms, power outages, labor difficulty, equipment failure, supplier problems or other difficulties that might prevent performance according to this agreement.
- 21. SHPL assumes no liability for personal injury to the distributor or the third party from use or mishandling of any of products promoted by SHPL.
- 22. SHPL reserves the right and full authority to accept or reject any IBO application or any sales order of its products. Such refusal is solely within the discretion of SHPL. No rights of action against SHPL will arise because of any such acceptance or refusal.
- 23. SHPL reserves the right to terminate this agreement immediately upon receipt of sufficient information that an IBO has violated any terms or conditions of this agreement or has otherwise acted illegally or unethically.
- 24. This Agreement shall be deemed in effect upon its receipt and acceptance by SHPL at its Headquarters located in Kolkata through either a hard copy or digitally during online sign up.
- 25. These terms and conditions are governed by Indian laws. IBO agrees that any claim, dispute or other difference between them and SHPL shall be exclusively resolved by the authority at Kolkata, West Bengal. All disputes pertaining to this registration will be subject to Kolkata jurisdiction.
